The Coos County Planning Department is in the process of updating records regarding Family Medical Hardship Dwellings (Hardship Dwelling). Our records indicate that a Hardship Dwelling is authorized for the above location.

A Hardship Dwelling can be a manufactured dwelling or recreational vehicle, or the temporary residential use of an existing building, in conjunction with an existing dwelling as a temporary use for the term of a hardship suffered by the existing resident or a relative. Within three (3) months of the end of the hardship, the manufactured dwelling or recreational vehicle shall be removed or demolished or, in the case of an existing building, the building shall be removed, demolished or returned to an allowed nonresidential use. Every two years, the permit shall be reviewed for reauthorization. This is the property owner's responsibility to submit for reauthorization. As used in this section, "hardship" means a medical hardship or hardship for the care of an aged or infirm person or persons.

This is a courteous reminder that the permit that is associated with this property is due to expire on 02/04/2023 . If your permit has expired, and you failed to renew it with the Planning Department, you may be required to pay an after-the-fact fee to reinstate the permit. Please fill out the attached form and check one of the boxes on page two to indicate the status of the hardship dwelling. Then, return the form along with the appropriate fee for renewal or reinstatement of the permit. It is the responsibility of the property owner(s) to ensure compliance is met and maintained. A response shall be provided within 30 days of the date of this letter; failure to do so may result in enforcement action being taken to ensure compliance.
