On August 1, 2023, the Board of Commissioners Adopted Final Decision and Order No. 23-06-006PL. The landowner, Stein Family Credit Shelter Trust, requested a rezone of Township 29S, Range 15W, Section 13, Tax Lots 600, located south of the city of Bandon. The subject property is currently split zoned between Exclusive Farm Use (EFU), Forest with a mixed use overlay (F/MU) and Minor Estuary & Shorelands (MES). The application request was approved to change the zone designation from Forest with a mixed use overlay to Exclusive Farm Use (EFU) zoning district.
