On February 20<sup>th</sup> 2024, the Board of Commissioners Adopted Final Decision and Order No. 23-12-010PL. The landowner, Ron LaFranchi, requested a plan amendment to amend the existing Industrial zone qualifier of Township 28S, Range 12W, Section 07C, Tax Lots 101 and 1000, located south of the city of Coquille. Tax Lot 101 is currently zoned Qualified-Industrial (Q-IND), and Tax Lot 1000 is Coquille River Estuary Management Plan (CREMP), Industrial Shoreland Segment 54 (54-INDS) The application request was approved.
